

FALL 2025 COHORT SELECTIVE ADMISSIONS REQUIREMENTS

Fall prerequisite courses may still be in progress when you submit your Dental Hygiene application. Your application will not be considered complete and therefore no acceptance/denial will be determined until after the grades for the prerequisite courses have been posted. Your final grades will be assessed at the end of the semester and your acceptance into the program will be based on your grades meeting the program's selection requirements.

Students taking prerequisite courses at SLCC must complete all courses considered for application by the end of the fall semester prior to the application deadline of January 15. Students using transfer credit for prerequisite requirements must have transfer courses completed and transcripts submitted to the Transfer Evaluation Office no later than August 31 prior to the application opening of October 1.

This is a selective process using points for grades, science GPA, completion of your observation hours, interview(s), and any additional preferred but not required components submitted. Those students with complete applications (all prerequisite courses complete with required grades, and all other documentation completed) will receive acceptance/denial to the program following the application deadline.

BIOL 2060/2065, BIOL 2320/2325, BIOL 2420/2425, CHEM 1110 & CHEM 1115 must be completed within five years and require a C+ grade or better. The remaining prerequisite courses require a C grade or better.

*MATH 1010 w/C grade or better or appropriate placement score into MATH 1050 is a prerequisite to CHEM 1110.

IMPORTANT NOTES ABOUT TRANSFER CREDIT

- It is the applicant's responsibility to make sure their transfer credit has been fully transferred to SLCC prior to the program's application deadlines.
- If a student has courses they are transferring from another school, their transcripts must be evaluated by the SLCC Transfer Evaluation Office and their **courses must be posted to SLCC DegreeWorks (their MySLCC account)**, before the program's application deadline. IT CAN TAKE SEVERAL WEEKS FOR TRANSCRIPTS TO BE EVALUATED.
- Students should declare Health Sciences as their Area of Study, and Dental Hygiene as the Program of Study when applying to SLCC. If the program of study does not match the information submitted on the transfer evaluation request, courses applicable to the program may not be transferred to SLCC.

VERIFICATION OF HIGH SCHOOL GRADUATION OR EQUIVALENT (GED)

Proof of high school graduation is required to apply. Documentation may include a transcript, diploma, or a letter of explanation if you do not have supporting documentation. ***You will be required to upload this information as part of your application.***

OBSERVATION HOURS

You are required to complete 25 observation hours with a Registered Clinical Dental Hygienist in a dental setting. There must be a Supervising RDH at the site to sign and date the form. You cannot be paid for your observation hours or use work time. Health care professional dress is required. Print this [observation form](#), have your supervising RDH

document and sign it, and submit it as part of your application. **Observation hours must have been completed within two years prior to applying to the program.**

PREFERRED BUT NOT REQUIRED

Applicants who submit documentation showing the following experiences may be given extra consideration for the program if they have fulfilled all the program application requirements.

- **Graduation from a CODA Accredited Dental Assistant program.**
- **Hands-On Dental Assistant work experience** (Must have worked full time, for at least 6 months) – Applicants must submit a signed letter from your employer (on letterhead) that states your job title, that you worked full time and the duration of your employment.
- **Worked in healthcare outside of the dental field with direct, hands-on patient care for a minimum of 12 months** - Must submit a signed letter from your employer (on letterhead) that states your job title and the duration of your employment.
- **Graduated from an AHEC program or completed a MA or CNA certification within the last five years** – Must submit certification.
- **Community Engagement** - Applicants that have demonstrated a willingness to serve others through volunteer community engagement will receive additional consideration on their application. Community engagement can be volunteering at food banks, homeless shelters, emergency assistance programs, neighborhood cleanup programs, etc.

Community Engagement Criteria:

- Engagement should have occurred within the last five years and since high school graduation
- Must be performed within the state of Utah
- Continual experiences encouraged
- Must be served without payment or reward
- Service engagement with underserved groups or populations is encouraged
- Only one experience will be considered for the application

Submit a letter of recommendation from the mentor who supervised community engagement as part of your application. The letter must discuss the type of service, length of time committed to serving, and where the service was performed.

Any document or information you wish to have considered on your application must be uploaded while completing your application. Additional documentation cannot be considered once you have submitted your application.

INTERVIEWS

Prior to acceptance, qualified candidates will be contacted within 10 days after the application submission period ends to sign up for a **mandatory** Multiple Mini Interview

(MMI) and a possible Standardized Video Interview (SVI). MMI's will be held in-person on Friday, February 14th, 2025, and Friday, February 21st, 2025, from 9:00 a.m – 2:00 p.m. Candidates will be required to sign up for a one-hour time slot on one of the days to complete the MMI. SVI's will be online, instructions for completion will be sent via your bruinmail.
